## **TERMS AND CONDITIONS OF CHARTER**



## **DEPOSIT TERMS**

To secure a date, a 50% deposit of the yacht hire is due upon booking. A charter agreement will be issued and must be signed by the charter broker and charter client.

## **PAYMENTS DUE**

Full payment and menu choices are to be finalised 10 days prior to the charter date with final guest numbers to be confirmed 14 days prior so the final balance invoice can be accurately calculated. The final balance of funds is to be received as cleared funds no later than 10 days prior to the charter date.

#### CANCELLATION

If the charter is cancelled in writing more than 30 days from the charter date, we will give a full refund of monies received minus a \$500 administration fee. If the charter is cancelled within 30 days from the charter date, the deposit paid will be forfeited.

## **DEFINITIONS**

The following terms shall have the following meanings in this Agreement (whether capitalised or not): Agent means the Agent or Broker who has introduced the Charterer to Oneworld for the purposes of performing this Charter.

Agreement means this Agreement between the Owner and the Charterer

Captain means the master of the Vessel

Charter means the provision of the Vessel to the Charterer for the period stated for the relative Charter Fee

Charter Guest means any person onboard the Vessel as a part of the Charter

Charter Manager means the representative of Oneworld authorised by the Owner to manage the Charter

Charterer is the person responsible for the payment of the Charter Fee and the charter guests on board the Vessel.

COVID-19 shall mean the type of coronavirus known as "COVID-19"

Governmental Entity shall mean relevant government entities including the NSW, QLD and Australian Government and their respective health departments

Oneworld refers to OWC Australia Pty Ltd

Security Deposit means the bond payable by the Charterer.

Vessel is M/Y Oneworld

#### **EVENT CONFIRMATION**

Your event booking is not confirmed until the deposit payment is received, and the contract has been signed by the Agent and the Charterer.



### SCHEDULE OF PAYMENTS

Payments must be paid to OWC Australia Pty Ltd in accordance with the schedule below. If the balance payment is not paid by the due date, the deposit will be forfeited, and the charter will be cancelled.

Balance invoice (remaining yacht hire and full payment of catering, beverage, waitstaff and charter additions)	10 days prior to the charter commencement date
Security deposit	3 days prior to the charter commencement date (credit card authorisation or EFT)

Additional charges (for any extra charges	Within 7 days of charter conclusion
incurred on the day)	date

No guest will be able to board the vessel until payment is made in full.

## CHARTER CAPACITY

The maximum number of guests permitted to board the vessel for the charter can be found on the balance invoice.

For the purpose of yacht hire fees, catering, beverage, waitstaff and charter additions, unless we receive written notice of any reduction or increase in numbers no later than 3 working days prior to your charter commencement date, we shall consider the guest numbers stated in the balance invoice to be correct and all original charges will apply and are payable in full.

Should the guest numbers on the day exceed the number of guests in the balance invoice, the Captain has sole discretion whether or not to allow additional guests to board the vessel. If the additional guests are allowed to board the vessel, the Charterer will be liable for the additional fees relating to these guests, including but not limited to additional yacht hire, catering and beverage costs.

Refunds will not be given for no-shows or latecomers.



#### ACCESS TO THE VESSEL

The Charterer and their guests may only board the vessel at the time their booking is scheduled to commence. Access prior to this time (e.g. for event setup) must be approved in writing by Oneworld at least 48 hours prior to the Charter commencing.

The Charterer and their guests shall vacate the vessel by the agreed time set out on the balance invoice. Specific arrangements to extend must be confirmed by the Captain of the Vessel. Any extension of time or failure to vacate the premises at the agreed time shall incur hire and staff fees for each additional hour, which may be deducted from the security deposit.

Full access to the yacht including lower deck cabins will be managed on a case-by-case basis and should be discussed with the Charter Manager at least 24 hours prior to the charter commencing. Oneworld reserves the right to close any areas off in order to protect the vessel.

#### GUEST CONDUCT AND SAFETY

The Charterer is responsible for the behaviour, security and safety of themselves, their guests and any associated contractors whilst they are on board the Vessel.

The Charterer shall observe and comply with all instructions given by Oneworld crew and with the provisions of this Agreement.

The Charterer agrees to ensure that all their guests are aware of the provisions in this Agreement.

Nudity, strippers and topless waiters are not permitted as part of any charter onboard Oneworld It is prohibited for any person to use, sell, purchase or be under the influence of any illegal substance onboard the Vessel. Any guest found to be under the influence of an illegal substance will be immediately removed from the Vessel at the Charterer's expense.

Oneworld crew reserve the right to request the removal of any guest behaving in a dangerous, disorderly, argumentative, offensive, illegal or objectionable way.

The safety of our crew and guests is our first priority. If the behaviour of any charter guest threatens this safety, police will be notified, and the charter will be immediately suspended.

Any children onboard shall remain under direct supervision of an adult at all times.

#### **RESPONSIBLE SERVICE OF ALCOHOL**

RSA regulations apply onboard Oneworld. Oneworld crew reserve the right to refuse service to anyone underage or overly intoxicated.

To ensure the safety of guests returning to dock, the bar will be closed 30 minutes prior to disembarking.

#### SHOES

Oneworld has a strict no shoe policy on board. A welcome mat and chairs will be provided for guests embarking the yacht to remove their shoes. All guest's shoes will be stowed safely on board during the charter.



#### TOILETS / SHOWERS / CABINS

Oneworld has two bathrooms located on the main deck available for use. Other guest areas and bathrooms will be available subject to the number of guests on board during the charter.

Cabins, including beds, are not available for use during day charters unless agreed in writing prior to the charter.

Showers are not available to use at any time, there is a freshwater shower located on the aft swim platform for any guest wanting to rinse off after swimming.

Guests need to ensure that no sanitary items or any other non-biodegradable waste are flushed down the toilets. Bins are provided and the cost to repair any blockages will be taken from the event bond.

#### CATERING

Food is not to be taken into any of the 5 guest suites. Consumption of food will be limited to the main guest areas of the yacht.

Menus contain allergens and are prepared in kitchens that handle nuts, shellfish, gluten and eggs. Whilst all reasonable efforts are taken to accommodate guest dietary needs, Oneworld cannot guarantee that food will be allergy free. Any dietary requirements are required to be ordered and confirmed 7 days prior to the event.

#### MUSIC

Oneworld's music system will be available during charters. Volume and control will be managed by the yacht's crew and any DJ equipment or sound systems must be discussed with the Captain/Charter Manager prior to commencement. If you would like your music to be played, please create a public Spotify playlist in advance so the crew can download and play for you on the day.

#### SMOKING

Smoking and vaping are permitted on the aft swim platform area and only while the yacht is at anchor.

Smoking and vaping are not permitted anywhere else on the vessel. If any guests smoke or vape inside the vessel, cleaning costs will be deducted from the security deposit.

#### SWIMMING, WATER SPORTS & JACUZZI

All in-water activities are to be confirmed at the time of booking the charter. Lifeguards need to be employed for safety at the Charterers expense.

Anyone who wishes to participate in any water activities will not be permitted to consume any alcohol. Day charter guests are to supply their own towels and no more than 30 guests are allowed in the water at any one time.

The jacuzzi and water slide are not available for use on charter unless agreed and paid for prior to the charter.



#### WATER TAXIS

Any water taxi embarking / disembarking must be approved by the Captain. Water taxis are to be arranged at the Charterer's own expense.

#### MEDIA

Oneworld may feature media collected from the client's events on our social media channels and website. This may include posting images, testimonials, videos and audio. It is the responsibility of the Charterer to inform their guests of this provision.

## STANDARD CANCELLATION POLICY

Cancellation more than 60 days prior: Your deposit will be refunded less a \$500 administrative fee. Cancellation between 60-14 days prior: Deposit is non-refundable.

Cancellation less than 14 days prior: Full payment is due and payable with no monies refundable. If full payment has not been received, Oneworld is entitled to recover from you the outstanding amount.

In the above circumstances, consideration will be given to provisioning and staffing costs incurred due to cancellation.

Cancellations must be made in writing via email to info@oneworldcharters.com.

Where monies are refunded in the event of any cancellation, the Agent is entitled to commission equal to the pro-rata commission amount of monies retained only, with no further penalties to apply.

#### COVID-19

Government Mandated Shutdowns or Government Enforced Restrictions may be announced that prevent your Charter from proceeding. For this clause to apply, the shutdown/restriction must affect 30% or more of your attendees (e.g. border closures) or prevent Oneworld from performing the charter (e.g. new venue capacity limits). The shutdown/restriction must also apply on the date of your charter. If the shutdown/restriction is announced:

- more than 72 hours before your charter start: you are entitled to a full refund of all payments made.
- less than 72 hours before your charter start: 50% of the charter costs remain due and payable and 50% is refundable.

Anyone who tests positive to COVID-19 on a PCR or RAT test in the 7 days prior to the charter will not be able to board the Vessel. Guests testing positive to COVID-19 will not be considered grounds to cancel a charter.



#### FORCE MAJEURE CANCELLATION

Oneworld may cancel and reschedule bookings for weather, safety, vessel inoperability, sale of the vessel or any other reason at the Captain's discretion. In this unlikely event, Oneworld reserves the right to substitute a suitable alternative vessel or an alternative charter date suitable to both parties. If no alternative vessel or date can be found, Oneworld will refund any deposit or payments made with no further penalty.

#### VESSEL SALE

If the Owner sells the vessel after this agreement is executed but prior to the Charter Date, the Owner agrees to give notice of such sale to the Agent. If the new owner agrees to undertake to perform this Charter on the same conditions then this Charter Agreement will be assigned to the new Owner to perform the Charter. Only if the Charter is not precisely the same terms and conditions then you have a right to decline to sign the new Charter Agreement.

Any deposits paid under this existing Charter Agreement will also be reassigned to the new Owner.

#### SECURITY DEPOSIT

- 1.A security deposit of \$5,000 will be held for all charters.
- 2. The security deposit needs to be paid 3 days prior to the charter date and can be taken in the form of a credit card authorisation or paid via EFT.
- 3. The bond will not be repaid at Oneworld's sole discretion in the event of breach of charter conditions, loss or damage to the vessel or fittings, unreasonable or excessive uncleanliness, unruly behaviour, smoking or vaping indoors, causing the Captain to terminate the charter early in concern of the safety of the crew or the vessel.

## DAMAGE TO THE VESSEL

- 1. The Charterer shall notify Oneworld staff immediately on becoming aware of any damage or loss to the Vessel, its facilities or equipment and of any injury to any person whatsoever during the charter.
- 2. The Charterer shall be responsible for the cost of making good any damage or loss caused to the vessel and its furniture, fittings and equipment arising out of and/or in the course of the Charterer's Charter.

## ADDITIONAL CHARGES

Any additional charges on the day of service are to be immediately deducted from the security deposit. This includes but is not limited to extensions of charter, additional guests, additional services, pay-on-consumption beverages, waiting time for embarking and disembarking at wharves, water taxis and any other additional charges notified by Oneworld.

If additional charges or cost of damages is greater than the amount of the security deposit, the Charterer (or Agent) will be forwarded an invoice for settlement within 7 days.

Any Agent to this Agreement agrees to pay the invoice by the due date and recover funds from their Client.



#### SUITABILITY

It is acknowledged that the Charterer is satisfied with the suitability of the Yacht for the Charter Period.

The Charter understands the inherent risks and dangers onboard the Yacht. All passengers participate in the Charter entirely at their own risk.

## ONEWORLD'S LIABILITY

It is a condition of the booking that the liability of Oneworld, its owners, employees and subcontractors is agreed to be limited in accordance with the Limitations of Liabilities and Maritime Claims Act 1989 (Cth) and that any claim for loss or damage must be notified in writing within 7 days from the day of the Charter and any court action, suit or proceeding must be brought within 365 days of the Charter date.

The Charterer agrees that any items left unattended onboard the vessel are left at the Charterer's and/or guests own risk and Oneworld takes no responsibility for such unattended items.

#### CHARTERER'S LIABILITY

The Charterer is liable for themselves, their employees and any contractors whom they may engage in relation to the event and indemnifies Oneworld, all Oneworld employees and caterers against any claims, actions losses, demands, damages and expenses for which Oneworld, its employees and caterers shall or may become liable or suffer in respect of damage to Oneworld's property or injury or death of persons arising out of any wilful, unlawful or negligent act or omission of the Charterer, its employees, agents or subcontractors in connection with this event.

It is the responsibility of the Charterer to obtain and keep current insurance against such liability during the term of this contract and ensure that all contractors under their direction are similarly insured.

#### JURISDICTION

In the event that any dispute arises in connection with this Agreement, the parties agree to submit to the jurisdiction of the court of New South Wales.

## SIGNATURES & SIGNATORIES

If you are accepting the terms of this Agreement on behalf of the Charterer, you warrant and confirm that you have authority to bind the Charterer to the terms of this Agreement.

Failure to comply with any of the above provisions will result in immediate suspension of the Charter without refund.
